SCAA President Marshall McAbee



Bylaw Change Recommendations

Below are recommended changes to the bylaws for the SC Auctioneers Association. The language that is underlined is recommended additions and the language that is struck thru reflects proposed deletions from the current bylaws. Please review carefully and call the SCAA office if you have questions. These recommendations will be voted on at the membership meeting held on Saturday, January 11, 2020.

Article VIII - Annual Dues

Each auctioneer member shall pay an annual due as set by the board with membership approval.

Each affiliate shall pay annual dues as set by the board with membership approval. Said dues shall be paid in advance or before the first day of July January each year. Dues are from July1 – June 30-January 1 thru December 31. Renewal statements will consist of three (3) mailings which will be mailed at intervals of 90-60-30 days.

For New Members Only: annual dues shall be prorated from date of membership for auctioneer members and affiliated members joining the association after $July 31^{st}$ January 31.

Delinquent Dues: Any membership on which the dues are not paid by July 1st <u>March 1</u> due date will be suspended with that member losing voting rights, privileges and benefits of membership until such time said dues are paid in full.

<u>Section 4</u> Resignation, Suspension or Expulsion No member shall be entitled to any refund of any dues upon resignation, suspension or expulsion from the Association.

<u>Section 5</u> Fiscal Year The fiscal year shall be from July 1 to June 30 of each year. January 1 to December 31.
