## Local Auctioneer Calls Bid For World Record Sign Sale

Richmond Auctions of Greenville, South Carolina was host to a two-day auction showcase on Friday, August 26th and Saturday, August 27th with the highlight of the event being the sale of a New Old Stock 48" double side porcelain Musgo Gasoline sign with a total selling price plus buyer's fee of \$1,552.500.

Musgo Gasoline was in business in 1929 in Muskegon, Michigan.

Local auctioneer, David J. Meares, CAI, GPPA, CAS, called the bids for the record setting sale at auction. The professional auction crew of David J. Meares, LLC was contracted by Richmond Auction to perform the auction day services.



Jordan Richmond of Richmond Auctions said the World Record Sign Sale was the result of a mixture of rarity and scarcity for the item.

Richmond said there are only about 20 known signs like this, and this particular sign was "perfect new old stock" and is "the best known in the world".

According to Richmond, the Musgo Gasoline Company was only in business for about 3 months in 1929 and for several reasons, including the great depression, which came along about that time, the company went out of business. The sign company that was making the signs for Musgo Gas also went out of business.

A plumber bought the sign business building and was using the remaining signs as septic tank covers, Richmond said. Apparently, someone had taken one home for a keepsake and the record-breaking sign that sold at this auction was found in an attic in Michigan, where it had been for 100 years.

Richmond said, "Only a handful are known to exist" and "there are only a few collectors that would pay that much for a sign".

Until this auction, the most paid for a sign was \$400,000, and before that, the record was \$240,000 for a sign sold in 2016, he said.

"It set a world record", Richmond said.
